APPROVAL OF MINUTES OF APRIL 21, 2025

DIRECTOR OF COMMUNITY AND ECONOMIC DEVELOPMENT REPORT

- Status of development projects in the Township
 - o Director Sweeney referred to the Development Status Report in the Board's packet and reviewed the following:
 - The Merritts Properties land development plan has been withdrawn. Solicitor Miner added that this is under litigation at this point. There was a brief discussion on this item and Director Sweeney stated he will be meeting with Solicitor Miner shortly for this property located at 1413 Arcona Road. Their appeal date is May 2nd.

- Wawa will go before the Board of Commissioners for conditional approval on the 25th of August.
- Liberty Forge will be going before the Planning Commission tomorrow night, August 19th.
- Form 990 Filing Date Extension to November 18, 2025.
 - Director Sweeney explained the Development Authority filing and audit is done in conjunction with the Township Audit and since the Township Audit has not been done yet, this has not been completed either. Discussion ensued.
- Lower Allen Commons NPDES Permit update:
 - Director Sweeney explained that in the Board's packets is included the information concerning this permit. The Development Authority is now completely off of the NPDES permit and completely out of the Lower Allen Commons project. The Permit is now in the hands of the owner's, Mountz Jewelers.
